## Junior Golf Camp (9:00am - 12:30pm)

We start camp early (8:45am) on Monday for check-in and orientation.

The camp is designed for beginners and young golfers who want to learn and improve their golf skills and focus on the fundamentals of the game. Your child will learn the proper techniques for putting, chipping, full swing, as well as the rules and etiquette of golf. Emerald Hills Golf Course staff and Pro believes the best way to teach your child is through on-the-course training. That's why we close our course to public and member golfers during the Junior Golf camp. Each day our counselors will bring your children to different areas on our course that will provide a unique on-the-course experience that will enrich both their golfing skills and camp experience. At the end of the camp the campers will receive an Emerald Hills tee shirt, golf handouts and a certificate for passing Emerald Hills School of Golf. Campers can bring their own clubs or clubs can be rented from us for an additional \$20 per week. Hot lunch is also provided each day.

## After Care Program (12:30pm - 5:00pm)

This part of the program is a continuation of the first part of the day. It will begin at 12:30 and will go until 5:00pm. At 12:30pm all the campers in this program will meet up and be asked where they would like to go for the day. They will have a choice between the swimming at our pool (certified lifeguards on duty) or be able to continue to work on their golf skills. If they choose to go swimming at the pool we will have a counselor bring them to the pool in which they will be able to have fun and swim till 3:00pm. If they choose to continue to golf an instructor will take them back onto the course to play a round of golf. This is a great way to put what they have learned that day to the test and at the same time fix certain areas that still need some work. Both the swimmers and golfer will meet up at 3:15 on the deck in front of the pro shop where they will have a 20-minute snack time. After snacks, it will be free time where they can relax on the deck or golf in the practice area.

## WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

*The purpose of the following is to inform the undersigned of your rights when your camper is participating in the Emerald Hills Junior Golf Camp and/or its Aftercare Program. For purposes of this document, Emerald Hills Golf Course will be referred to as EMGC.*

- Assumption of Risk:** The undersigned, as parent and/or guardian of Camper acknowledges that you are aware of the inherent risks of injury, death, and property damage involved in all camp activities, including without limitation, risks due to drowning, near drowning, falls, being hit by golf balls, actions of other people, including, but not limited to , participants, volunteers and spectators. THE UNDERSIGNED KNOWINGLY ASSUME ANY AND ALL RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE, WHETHER THOSE RISKS ARE KNOWN OR UNKNOWN, STEMMING FROM THEIR CAMPER'S PARTICIPATION IN EHJGC AND ALL RELATED ACTIVITIES, INCLUDING BUT NOT LIMITED TO, ANY ACTIVITIES OF EHJGC AFTERCARE PROGRAM.
- Release and Waiver:** The undersigned, as parent and/or guardian of the Camper hereby release all officers, agents, volunteers and employees of EHGC and its Aftercare Program and EHGC ("Releasees") and all other related parties from all liability to (i) you as parent and/or guardian, and (ii) Camper, and (iii) principals, employees, agents, representatives, guardians, successors, assigns, heirs, and next of kin for all liability, claims, damages and demands from personal injury, death, or property damages, arising from or related to this Agreement or to activities involved in EHGC or its Aftercare Program. This release includes, without limitation, any personal injury, death, or property damage caused by the active or passive negligence of any of the released parties, except for those caused by the willful misconduct, gross negligence or intentional torts of the Releasees.
- Indemnification and Hold Harmless:** The undersigned also hereby agrees to INDEMNIFY AND HOLD HARMLESS all officers, agents, volunteers and employees of EHGC and its Aftercare Program and EHGC ("Releasees") from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities arising from or in any way related to Camper's participation in EMJGC and its Aftercare Program and all related activities, except for those arising out of willful misconduct, gross negligence or intentional torts of the Releasees.
- Refund Policy:** The undersigned acknowledges that camp fees are not refundable. If the undersigned cancels two weeks prior to enrolled camp date, the undersigned's camp fees may be applied to a future EHGC during 2015 or 2016 golf season.
- Session Changes:** The undersigned acknowledges that any session change requests will be subject to a \$40 fee if made less than two weeks prior to Camper's enrolled camp date.
- Permission to Use Pictures of Camper:** The undersigned agrees to allow, without compensation, pictures of Camper to appear and be used in material, regardless of media form, promoting EHJGC and/or its events and activities.
- Acknowledgment of No Physical Impairment:** The undersigned acknowledges and certifies that Camper is in good health and fully able to participate in all activities of the EHGC and its Aftercare Program, including, but not limited to, all activities associated with golf and swimming, and that the undersigned knows of no restrictions, physical impairments, or any other facts, which in any manner limit Camper's participation in such program.
- Consent to Treatment of Minor:** In the event of a sudden illness, accident or injury which may occur while Camper is engaged in any activity supervised by EHGC, including any Aftercare Program run by EHGC, when neither parent or guardian can be contacted, the undersigned hereby gives his/her consent for emergency medical treatments. The consent allows the counselors of EHJGC and its Aftercare Program to provide and approve emergency care and transportation should it be required and to give Camper prescribed medication. In the event of urgent medical circumstances, medical treatment may be given by any doctor/dentist licensed under the laws of State of California.
- Acknowledgment of Understanding.** The undersigned has read this Conditions of Enrollment, Waiver of Liability, Assumption of Risk and Indemnity Agreement and fully understands its terms and intends that the undersigned's signature will be a complete and unconditional release of liability to the greatest extent allowed by law.
